ANNUAL GENERAL MEETING in May 1996 was addressed by Senator Sid Spindler. His theme was "When did you last profit from child labour?-- what we and our government can do"

FEDERAL CONFERENCE in 1996 was held in Perth. South Australia was represented by Heather Southcott and Deepak Bista. We submitted resolutions on

- *tolerance and respect for indigenous Aboriginal culture being an essential part of reconciliation
- *calling for a labelling system to raise awareness of the use of Child Labour within the Asia Pacific area.
- *calling for recognition by the government of all Australian Police and others who served with the UN Peace Keeping Forces up to 1988 and who were included in the 1988 Nobel Peace Prize award for Peacekeeping

UN DAY EVENTS (October 24th)

- * a wreath was laid by Dr Malcolm McArthur on behalf of UNAA at the ceremony at the War Memorial organised by S.A. Peacekeepers Association.
- *UNAA(SA) and UNIFEM co-hosted a dinner with Mrs Anne Hetzel as guest speaker \$300 each was given to UNIFEM projects and to the KIWANIs/UNICEF project to eliminate iodine deficiency diseases.

CHRISTMAS LUNCH enabled us to thank all our volunteers (office and executive) Special recognition was given to Miss Barbara Godson who had retired after more than 20 years as a volunteer.

UNITY MAGAZINE We contribute \$2 per head (approximately the cost of one issue) per member to help defray the cost to UNAA; it remains a most effective method of communicating.

FINANCES Our thanks to our efficient book-keeper (Harriet Glen) who has now moved to Canberra. Also to Geoff Purdie, our Treasurer, who is not able to continue in this role due to pressure of work.

NORMAN PERCY COLE GRANT We are grateful for a \$4000 grant which was used to support our work in schools, in assisting students to attend National conferences and also was made available as encouragement grants during Childrens Week.

STATE GOVERNMENT GRANT \$3500 continues to be made available by the government.

VOLUNTEER OFFICE STAFF

We have missed Barbara Godson and Mollie Hopkins but have welcomed Shirley Gitsham and Ron Hall. We thank our continuing stalwarts Mabs Tassell, Michael Shepherd, Cynthia James. We also thank Lynwen Maeder and Hugh Bray who are unable to continue as volunteers.

STATUS OF WOMEN COMMITTEE

ANNUAL REPORT 1996 - 1997

The Status of Women Committee is a committee of the South Australian Division of the United Nations of Australia. The terms of reference of our Committee are to examine and where necessary to take action with regard to all factors - political, educational, economic, legal and social - which affect the equality of the status of men and women. In particular, to study and help implement the World Plan of Action, which was ratified at the World Conference on Women. We are committed to upholding the United Nations Convention on the Elimination of Discrimination Against Women (C.E.D.A.W.), adopted by the General Assembly of the United Nations in December 1979.

Membership is open to any organisation or individual interested in promoting women's rights as laid down in the United Nations Decade for Women. Currently, 20 women's organisations are represented on our committee, and a number of individual members, many of whom have previously been organisational representatives.

MAJOR ISSUES:

Throughout this year, Status of Women Committee has maintained a strong interest in the issue of women prisoners, and has continued monitoring the progress of change at the Northfield women's prison. Over the past two years, members have visited the women's prison complex at Northfield on 6 occasions, the most recent being on 21st March 1997. Savannah Dawn, Acting Manager, Women's Information Service, was invited to our June 1996 meeting to speak about a pre-release information kit for women prisoners.

At our October meeting, Bea McGrath, social worker at Northfield Women's Prison spoke to us about various concerns relating to rehabilitation and management of women prisoners, and their need for post release support. Bea runs the Inside Out program for recently released women prisoners. October also saw the inaugural meeting of the Adelaide Women's Prison Support Group, with which we are closely associated, as three of our committee members serve on its Coordinating Committee. In conjunction with Women's Electoral Lobby (S.A.), we arranged to obtain surplus curtain material and carpet from the Torrens Building, and deliver to the Living Skills Unit at the Women's Prison.

In November the Status of Women Committee held a Public Meeting at which the guest speaker was Dr. Craig Raeside, forensic psychiatrist at James Nash House Northfield, who spoke on the topic "Understanding the Impact of Trauma in the Lives of Women Prisoners", based on his research findings into Post Traumatic Stress Disorder among women prisoners. A long and interesting discussion followed the presentation, and copies of the paper have been sent on request to several Members of Parliament, as well as interstate.

We have lobbied for and recently sought a grant to establish supervised emergency post release accommodation for women prisoners. A delegation has just met with the new Minister for Correctional Services, the Hon. Dorothy Kotz, to discuss a number of issues, including individual assessment and case management programs for women prisoners, incentives, separation of drug users from non-users, training and education opportunities for women, literacy programs, skills development, access to children, improvements to existing facilities, and health care and rehabilitation.

In May, Kaz Eaton, Director of the Working Women's Centre, and Christine Gates, from Dale Street Women's Health Centre were invited to speak to the Committee on issues concerning home based women Out workers in Adelaide: their low rates of pay, long hours and deadlines, occupational health and safety problems, and exploitation by sub-contractors.

In September, conjointly with the Equal Opportunity Commissioner, our Status of Women Committee again organised a low cost daytime lecture for women unable to attend the 1996 Mitchell Oration dinner. The guest speaker was Father Frank Brennan, whose topic was: "30 Years On: Do we need a Bill of Rights?".

Following the dismantling of the century old facade of the former South Adelaide Creche early in 1996, the Status of Women Committee participated in the lobbying and subsequent community consultations regarding its re-erection on a suitable site in the city. To date, the City Council has agreed in principle to Norman Street being the preferred site, and allocated \$20,000 towards the re-erection project.

OTHER ACTIVITIES

We have written to the Press and to the Police Minister regarding "gun laws", indicating our strong support for the abolition of automatic and semi-automatic weapons, have participated in the International Campaign to ban Land Mines; have lobbied appropriate Ministers regarding anomalies in WorkCover legislation; have written to the newspaper regarding inappropriate procedures used in the Royal Commission Into Aboriginal Women's Business at Hindmarsh Island, and been prepared to participate with other women's groups in a High Court case where the Catholic Bishops wished to intervene and challenge the legality and thus availability of abortion services in Australia.

We participated with Women Against Demeaning Images in the Billboard campaign coordinated by the National Women's Media Centre; provided a donation to assist a woman to attend the Violence, Abuse and Women's Citizenship Conference in the United Kingdom in November 1996; made a submission to a N.H.M.R.C. discussion paper on abortion and women's reproductive choices; and wrote to the Vice Chancellor and Dean of the Faculty of Arts at Adelaide University concerning plans for the restructuring of the Women's Studies Department.

In 1997, the Status of Women Committee wrote to the Standing Committee of Attorneys-General concerning the proposed Model Criminal Code on Non Fatal Offences Against the Person, and subsequently about the proposed Model Criminal Code on Sexual Offences Against the Person. We also wrote to the Federal Minister for Consumer Affairs concerning the loss of the Advertising Standards Council; sent a submission to the Senate Parliamentary Inquiry into Cuts in Legal Aid; lobbied South Australian Senators regarding the "Hindmarsh Island Bridge Bill" and "Native Title Amendment Bill"; and wrote to State Members of Parliament, Ministers and Government Departments in support of a funding proposal titled: "Accommodation Needs of Homeless Women".

In addition, various members of this Committee have attended many forums, seminars and functions on a diverse range of issues, including several reconciliation meetings with Aboriginal Women, Multi-Cultural seminars, and the highly successful UNIFEM Breakfast on March 10th, at which we displayed some brochures. In August, Alleyne Womersley completed her term as President, but agreed to continue as Honorary Secretary of the Committee. At the International Women's Day luncheon in March 1997, Alleyne was presented with a community service award.

FUTURE ACTIVITIES

This year, an expert international committee will be assessing the Australian Government's performance in implementing the C.E.D.A.W. Convention. Non-Government women's organisations have decided to prepare an Alternative Report to the official Government report, and submit it to the expert Committee. As the Status of Women Committee plans to be a contributor, the review of the Convention will provide an opportunity to focus on areas needing further attention, and will identify goals for future activities. In addition to assessing the Australian Government's compliance with the C.E.D.A.W. Convention, our Committee is monitoring the Government's implementation of its commitments to the World Platform for Action, which were presented to the Fourth World Conference on Women held in Beijing in 1995.

Non-government organisations are being encouraged to have an input into government discussions and preparations for the annual sessions of the United Nations Commission on the Status of Women. The United Nations Commission on the Status of Women has decided on the following themes as priorities for its 1997 session: Education and Training for Women; Women and the Economy; Women in Power and Decision-making; and Women and the Environment. Other themes from the World Platform for Action have been set for each year until the year 2000. With such an agenda, the Status of Women Committee will continue with renewed focus, energy and purpose to be part of a world wide movement of women dedicated to achieving significant improvements in all areas affecting the status of women.
